# Innovation in Art Education

# New Program, Long-Term Impact

WMA's education department has, for many years, responded to significant needs in area public schools. Without formalized, K-12 art education, students are missing key components in creative, intuitive learning, and WMA continually seeks to fill in gaps in visual arts instruction. With feedback from area educators, WMA transitioned Smudges: 3rd Grade Outreach into a field trip reimbursement program called Bus on Us, which launched in August 2017. The program is a response to the long-term needs of Wiregrass students, and provides yearly opportunities for students to have significant, hands-on experiences in visual art. Bringing students to the museum allows them greater access to exhibitions, promotes the educational value of field trips, and grows their commitment to civic participation. It also builds students' creative thinking skills, as well as tolerance, empathy, and an understanding of historical context through art.1

Bus on Us will more than triple the reach of the Smudges program, and is forging stronger relationships between area educators and museum staff. Funding for this program is provided by the Houston County Commission and the Southeast Alabama Community Foundation.

# Growth in Program Attendance and Engagement

WMA's longest running program, First Saturday Family Day, experienced significant growth in FY17. The come-and-go, hands-on art workshop held each first Saturday of the month now averages over 100 participants monthly in its four-hour timeframe. Other programs like Screen on the Green and Youth Art Classes also contributed to the rise in this program's audience. Summer camps, including WMA's traditional in-house camps, explored more advanced mediums and techniques and expanded offerings to teens. Outreach summer camps, with support from the Wiregrass Foundation, provided the same enriching camp experiences to participating students at the






Wiregrass Boys & Girls Club and Boys & Girls Club Hawk Houston at no charge to the students.

Artist-related programming created opportunities for adult learners to discover and cultivate their own creativity, too. Artist workshops from Darius Hill, Cindy Wagner, Sarah Marshall, and Susie Bowman and artist lectures from Guadalupe Lanning Robinson, Darius Hill, and Mark Leputa gave area residents accessibility

to distinguished artists and facilitated one-onone learning environments. Weekly youth art classes and monthly adult art classes at WMA built confidence of artists of all ages with new skills and techniques in a group classroom setting.

# Acquisitions and Collections Management

WMA added three new works to its Permanent Collections; two from Huntsville artist Cindy Wagner. *Bric-a-Brac and Falling to the Earth* reflect the artist's interest in the natural world through digital mediums. Both works were on display in Wagner's *Guest Room in the Unconscious Mind* exhibition held from January 20th - March 25th.

Last Attempt by Dothan artist Dale Kennington was also added to the Permanent Collections. The artwork has been a focal teaching point and source of inspiration for students on field trips this year.

In addition to new works added to the Permanent Collections, museum staff continued to make progress on a multi-year project in collections management with support from funding from the Alabama State Council on the Arts. Through careful records management, including object numbering, digitization of records, and cross-referencing, museum staff has been steadily improving its collection inventory practices, and this work will allow WMA to more efficiently access its resources for exhibitions. In the future, this ongoing work will allow the museum to give improved access to the Permanent Collections to artists, educators, other art institutions, and researchers.

# An Ongoing Commitment to Alabama Artists

WMA's 2017 exhibition schedule presented a platform for Alabama artists to show their evolving practices, and provided Wiregrass residents with plentiful opportunities to learn directly from them at artist lectures and workshops. With fifteen exhibitions featuring new and diverse works, the museum provided a channel for well-established artists to continue to tell their stories, as well as opened new doors to some artists for their first solo museum exhibition.

As we entered into a three-year period of Alabama bicentennial celebrations (2017-19), WMA's ongoing commitment to Alabama artists has become even more in focus. The museum's galleries dedicated to the Permanent Collection featured work exclusively from Alabama artists, including Dothan's own Dale Kennington, and other prominent artists like Scott Stephens, Amy Pleasant, and Gary Chapman. Butch Anthony's Museum of Wonder exhibition brought to life the 2017 bicentennial theme, "Discovering Our Places," by recreating his art environment in Seale, Alabama, and connecting Wiregrass residents to the distinct cultural and historical geography of a neighboring rural location in the state. WMA produced a catalog for this exhibition, giving an expanded look at the artist in context to the Alabama arts community.

FY 2017 exhibition support was provided by the Alabama State Council on the Arts and The Daniel Foundation of Alabama.

WMA is the visual arts hub of southeastern Alabama and provides high quality arts experiences for thousands of people each year. # Communication and Development

In FY17, WMA's external affairs focused on educating the general public on the museum's offerings, promoting its role as a cultural gathering-space, and building relationships within the business community. Significant local media coverage from traditional media outlets expanded the museum's reach, and the museum's social media following grew by 20% over the year.

Museum staff took part in National Museums Advocacy Day in Washington, D.C., in February, relaying the importance of a visual art museum and museum funding for rural communities in Alabama to elected representatives. Through increased advocacy at the local, state, and federal level, staff and board worked more diligently throughout the past year to educate leaders on the value of WMA for area residents.

Event fundraising for WMA served to boost the museum's profile with new audiences in the Wiregrass, celebrating art, community, food, and drink at Wine Experience and Yard Party for Art for a combined income of \$24,279. Fundraising events raised awareness of WMA's role in the region, built

community goodwill, and provided truly unique cultural experiences for residents and museum supporters to enjoy, whether that was tasting an Italian wine, enjoying musical acts from around the Southeast, or being an active part of an outdoor art installation.

This year's implementation of the corporate member program strengthened new and existing relationships in the business community, and built the basis for multi-year agreements of support that will grow WMA's Annual Fund. The corporate member program allows corporate leaders to re-invest in the arts and culture sector of the Wiregrass as a whole, and within their own organizations through the benefit of museum memberships for their employees. WMA's corporate members are advocates for the arts, and have a keen understanding of the mutually beneficial opportunities for economic and social growth between the business and arts communities.
